PROMOTER'S CONDITIONS

THE MEET

1. The Meet will be run at WOKING POOL IN THE PARK, KINGFIELD ROAD, WOKING, SURREY. GU22 9BA. It is a 6 lane, 25m Pool with anti-wave lane ropes, electronic timing and a full 6 lane display electronic scoreboard.
2. The Meet is licensed at Level 3. It will be run under current Swim England Laws and Swim England Technical Rules, and all swimmers must be registered with Swim England.
3. The Meet will be run as "age on the day" for swimmers aged 9 years and over on 14 December 2025. The age groups for this meet are as follows:
 - Male/Open 9, 10, 11, 12, 13, 14, 15 and over
 - Female 9, 10, 11, 12, 13, 14, 15 and over
4. The Female category is for birth sex females in accordance with Swim England's Transgender and Non-Binary Competition Policy. By entering the 'Female' category you confirm that your birth sex is female.

The Male/Open category is for birth sex males and any other swimmer who is not eligible for the female category.

5. A secondary strobe light will be available on request at the time of entry.
6. Events available to all swimmers are 50m, 100m and 200m in all strokes.

ENTRY

7. Swimmers must be Swim England registered as Club Compete with a Swim England number and a registered member of the entered club.
8. Entries will be accepted on a first come first served basis. The Promoter reserves the right to restrict entries, or to close entries early if the meet becomes fully subscribed.
9. In the event that the meet is oversubscribed, electronic entries will be accepted on a 'First Come First Served' basis. The Promoter's decision in this matter is final.
10. Confirmation of entries will be returned as soon as possible after the Closing Date and following receipt of a completed Summary Entry Form and supporting payment. Improved entry times will not be accepted after submission of the Entry Form.
11. The Meet is subject to upper and lower limit qualification times detailed in the attached table. All submitted entry times must be within the limits specified. Swimmers with a time outside of these limits are not eligible to enter, and any such entries received will forfeit their entry fee for that event. Woking SC reserves the right to check submitted times and to refuse entry to anyone who has breached this condition.

12. All entries must be made on HyTek. Clubs must download the Hy-Tek Team Manager file from <http://www.wokingsc.co.uk> and return the entry file to wokingsc.dasher@gmail.com. Full Team Manager instructions may also be found on <http://www.wokingsc.co.uk>. Payment must be made by direct bank transfer; details are provided on the Club Entry Summary Form. We cannot guarantee entry where we have received incomplete entry details.
13. The entry fee is £8.50 per event, to include the Swim England levy of 20p per swim.
14. As soon as possible after the closing date, we shall post a list of accepted and rejected entries on our website, together with any further necessary information. This information will also be emailed to the contact person for each club.
15. Entry data may be held on a computer or other electronic or non-electronic medium solely for the purposes of this competition and consent, as required by the General Data Protection Regulation 2018, to the holding of personal information in this way will be deemed to have been given by the submission of the entry. Personal data will be available for inspection subject to the regulation and the relevant Club policies.
16. If the meet is under-subscribed late entries may be accepted and time trials may be available to all swimmers at the Promoter's discretion and will be dependent upon space being available. Priority for time trials will be given to swimmers already entered in the Meet. All time trial entries will not be eligible for awards.

REFUNDS

17. Full refunds will only be given in the following circumstances:
 - i. Where it has been necessary to restrict entries.
 - ii. On receipt of proof of injury/ medical condition through a doctor's certificate (or equivalent).
 - iii. Due to any exceptional circumstance that is deemed appropriate by the Promoter.
18. No refunds will be given for incorrect entries.
19. The Promoter's decision is final.

POOLSIDE ACCESS AND PASSES

20. At all times, access to poolside will be limited to swimmers, coaches in possession of Poolside Passes, other Poolside Pass holders, and authorised Technical and Non-Technical Officials only.
21. Poolside passes will only be issued to DBS checked adults over the age of 18 who have passed all relevant qualifications.
22. A poolside pass is £15, to include entry to the pool, a programme, lunch and refreshments between sessions. Clubs are asked to observe latest Swim England guidance on adult to swimmer supervision ratio <https://www.swimming.org/swimengland/swim-england-relases-supervision-ratios-policy/> and should purchase poolside passes accordingly. Passes will be included in the Coaches' Pack, which will also contain any updated information. The only people allowed on poolside will be officials, meet organisation staff, swimmers and those displaying a poolside passes.
23. As the Pool in the Park is open to the public using other parts of the facility, all swimmers should wear suitable clothing and footwear when not poolside and use the cubicles in the changing village provided.
24. Valuables and personal possessions should not be left unattended - the Promoter does not accept responsibility for any loss or damage to property. Lockers are available for £1 refundable.



SIGN OUT

25. A cardless entry system will be operated at this meet. Swimmers must withdraw using the appropriate form no later than the start of each warm up period. Withdrawals prior to the meet can be made using the form via email addressed to wokingsc.dasher@gmail.com
26. Swimmers must report for their events in good time as directed by the Marshalls. Failure to report in time will result in the swimmer not being allowed to compete in the event.

WARM UP

27. Warm up will be available before each session. Timings are as shown on the programme which will be published online.
28. A swim down facility will be provided; clubs are required to supervise their swimmers using this facility.

AWARDS & PRESENTATIONS

29. All age groups swim together in the order of their submitted entry times.
30. Seeding will be slowest to fastest throughout based on submitted entry time. All age groups and grades will be swum together in the same event. All events are heat declared winner. The Meet will use over the top starts at the discretion of the Referee.
31. All events are Heat Declared Winner; there are no finals.
32. Medals will be given to 1st, 2nd, and 3rd place swimmers in each age group entered.
33. There will be Hot Heats where winner of the heat will receive a prize. Hot heats are randomly selected.
34. All Time Trial entries are marked on the programme by "X" as exhibition swims. These swims are not eligible for awards.

RESULTS

35. All results will be published on Meet Mobile.
36. All results will be submitted to Rankings within 48 hours.
37. There will be no "speeding tickets" for swimmers achieving times on the day faster than the published upper limit times for the meet entry.

SPECTATORS

38. Spectator entry per person will be £5.00 per session, £9.00 for 2 sessions, or £13.00 for all sessions.
39. Spectators are reminded that entry to change village and poolside are not permitted and the Promoter reserves the right to eject any persons without permits.

PHOTOGRAPHY / VIDEO RECORDING / MOBILE PHONES

40. Swimmers and Spectators are requested to follow the Swim England Wavepower guidelines regarding photography and the use on Social Media.

41. Those wishing to photograph / video are requested to focus on their own swimmer and avoid including other swimmers in the images.
42. Use of mobile phones or cameras is prohibited in the changing village and poolside.
43. No flash photography permitted at the start of each race.
44. Please switch mobile phones to silent mode to avoid disruption to starts.
45. Any concerns regarding photography and video recording at the event, please bring it to the attention of the Meet Promoter Frances Reeve.

OFFICIALS

46. Woking Swimming Club makes every effort to ensure the meet runs efficiently and effectively. We rely on the valuable contribution of officials who volunteer their time to support us. All clubs submitting entries are requested to assist in the running of the meet by providing the details of any licensed officials who are willing to assist at this meet. GENERAL

47. The Promoter, in conjunction with the Pool in the Park operator, reserves the right to refuse admission to any person.
48. The Promoter reserves the right to exclude any coach, swimmer or spectator from the meet who displays inappropriate behaviour or language.
49. All attendees must observe all safety precautions in operation at Pool in the Park and follow instructions of pool staff.
50. Leisure Lagoon and the Café is available at the Pool in the Park to the public. The Leisure Lagoon is out of bounds to all attendees, unless fees where applicable are paid to the centre.
51. There is a strict **NO NUTS** policy as we have attendees who have severe allergies. Please bear this in mind when packing food.
52. Swimmers are not permitted to wear watches or jewellery during races, except with the referee's discretion.
53. Woking SC adheres to the **Swim England Child Protection Policy Recommendations**.
54. All visiting clubs must ensure that team managers/coaches and officials comply with the Swim England Child Protection Policy.
55. Any situation not covered by the above meet conditions will be handled at the discretion of the promoters, Ben Larwood and Frances Reeve, contactable at wokingsc.dasher@gmail.com, who also reserve the right to make any changes that may be considered necessary for the safety, smooth running and discipline of the event.
